FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR ALTA VISTA

THIS FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR ALTA VISTA (this "Amendment") is made as of February 22, 2019, by LENNAR ARIZONA, INC., an Arizona corporation ("Declarant").

- 2. <u>No Overnight Parking</u>. The following is hereby appended to Section 4.15 of the Declaration: "Except as otherwise provided by applicable law, no Motor Vehicle owned or leased by an Owner, or Resident of a Lot or their guests may be parked overnight on a Street."
- 3. <u>Governing Law</u>. This Amendment shall be governed by and construed in accordance with the laws of the State of Arizona.
- 4. <u>Certification</u>. The parties certify that this Amendment has been approved as required by Section 15.2 of the Declaration, as authorized under Arizona Revised Statutes § 10-3704.
- 5. <u>Amendment</u>. Except as set forth in this Amendment, all of the terms and provisions of the Declaration shall remain in full force and effect. In the event of a conflict between the terms and provisions of this Amendment and the terms and provisions of the Declaration, the terms and provisions of this Amendment will govern and prevail.
